It is prohibited to fly an Remotely Piloted Aircraft (RPA) over restricted areas: government buildings, embassies, military bases, airports and aerodromes; all operation in these areas can be sanctioned if done without the proper authorization from the civil authority of Guatemala -DGAC-.
